ODHE

- Credentialing
 - o Now have 6 million vs 3 million in money for this issue
 - The priority is to get districts with low CCO enrolment
 - New RFP should be out in 2 weeks.
 - Incentives
 - Minimum of \$1000, 25% must go to the credentialed teacher
 - Must be a "new" program. Definition of what qualifies as new should be defined by October 1.
- Specific Pathways are in the budget
 - o Examples are: Nursing, Mental Health, & Education
 - ODHE is working on a tool kit for each of these specific pathways
 - Creating a PDF with examples of what the first 30 hours of a pathway could look like.
- SB 104
 - This bill is still in committee and is not currently law.
 - If passed this session, the earliest it could go in place would be February 2024
 - However, ODHE is working to quill the 2024 implementation. They are seeking to push it to 2025. (Important since all the informational meeting for the 2024-25 year by law are to be done by mid February)
- 3365.04 Compliance Auditing
 - The Auditor of State Office is charging HS to show how they are compliant with the CCP law via a survey.
 - They will use things such as EMIS information and School website
 - They originally requested compliance information on HS from Higher Ed. institutions as well.
 - It now appears they understand that this is not information that the Higher Ed. institutions can provide.
 - A Check list has been created to help secondary districts with the audit. This
 checklist should now be on the ODHE website
 - This is also a check list being created for higher ed. Institutions to help with their audit.
- Higher Ed. Pathway Waiver
 - Higher E. & Business Partnering Pathway.
 - Materials are being created, by ODHE, for this new pathway process

- Innovation waiver vs Business Pathway
 - Innovation waiver is between a secondary school and an institution of higher learning
 - Business pathway is between the institution of higher learning and a business / industry partner.
 - The business pathway is specific to a degree or credential that is in high demand in the workforce.
 - Both are seeking to work with underrepresented students, students who may be otherwise ineligible for CCP., both are academic, and working toward a career development

ODDEX

- A beast of its own
- o The lag from Summer data
 - ODDEX says the data will be released "soon"
 - "Soon" is currently undefined.
 - The 45 day window will begin once the data is released
- State Advisory Work Group
 - This group is working to give feedback and set a goal for Ohio.
 - The goal will be directed at the core for CCP to provide access especially to underrepresented groups.
- Ohio Department of Education
 - 7 members of the Department of Education filed a lawsuit against having the department that having the Governor's office
 - A Franklin County Judge has placed a temporary restraining order to halt the change. There is a hearing to be held October 2nd.
