ODHE Update

1. House Bill 33 has dropped. This is the Bi-annual Budget Proposal for operational budget.

3. Proposals to take note of from HB 33
 - a. 7.5 mil each year for credentialing of staff to teach CCP courses
 - i. There was a lot of discussion around the credentialing
 1. Is it possible to create a credentialing protocol that Ohio institutions would have closer agreement upon? Becky feels a diverse work group is needed under this topic.

 - b. Reaffirming ODHE's authority to check on CCP compliance
 - c. Pathway focus
 - i. Education
 - ii. Nursing,
 - iii. Mental Health
 - d. There is new guidance for military students whose family gets deployed. They would be allowed to WD from CCP course work with no penalty or to move to an online course.
 - e. On page 811 is FAFSA information on graduation requirements. The requirement is not tied to CCP
 4. Carly is working on mini modules that should help explain materials to staff and parents. She hopes to have these up at the end of February.
 5. ODHE website is still a work in progress to improve.
 6. New HS crosswalk is slated to come out. The goal is by the end of February.
