Notes

- **ODHE Report**
 - **ODHE and ODE will have a new name and logo.**
 - Department of Education and Workforce.
 - They are waiting on the Governor's appointment to see who will be the director of the new department. This is a new appointment.
 - The State Educational Board will still stand and the Superintendent will remain.
 - The transition date is October 3rd but, transition will be ongoing.
 - **Another new State department that was created is the Department of Youth.**
 - This will be a 2 year transition
 - It will have 7 current departments under its housing.
 - **Credentialing Money**
 - 3 million is in the bill for CCP teacher credentialing
 - There is an incentive to K-12 for first time programs CCP courses taught in house by a certified HS staff.
 - 25% of the grant must go directly to the teacher's pay.
 - ODHE will give guidance on this as soon as possible
 - The grant can be requested for the 2023-24 year.
 - **Senate Bill 104 is still alive and House Bill 219 is its companion bill.**

 - Becky's team will provide guidance as soon as they can.
 - The hope is requirements will begin in the 2024-25 year, but there is concern it might begin for Feb 2024
 - **Discussion on new credentialing guidelines for CCP instructors**
 - HLC will be the guiding association for credentialing of CCP instructors
 - It is likely there will be language toward alternative avenues for credentialing
 - There was concern about out-of-state transferability of CCP credits and how the credentialing alternatives could impact this.
