Governor Snyder's Marshall Plan's Impact on Concurrent Enrollment

The State of Michigan has unveiled the Marshall Plan for Talent Senate Bill 941-942 to help create a business and education collaboration. The goal of the Marshall Plan is to help students and adults prepare for careers of today and tomorrow by increasing career exploration, evolving current educational strategies towards competency based education, and to create multiple pathways to achieve success. The State of Michigan estimates that by the year 2024 there will be 811,055 high-demand career openings with \$49,094,842,059 in potential earnings (<u>www.michigan.gov/ted/</u>). It makes sense to keep our local talent in place by guiding students to a career path in these high demand careers. What better way than to begin exploring careers while still in middle and high school?

Career exploration expansion is being planned through multiple avenues. Career navigation tools such as MI Career Cruising and MI Bright future are two of the features already in plan in the Marshall Plan. These programs allow students to begin to plan for what it might be after high school and to take the necessary steps to make a dream a reality. According to the MI Bright Future website (www.mibrightfuture.org/) this program "addresses the long-term workforce needs in Michigan, especially in high-demand occupations, by supporting the development of an informed, educated, skilled and experienced talent pipeline. MI Bright Future is a partnership of k-12, workforce development, post-secondary partners, and chambers of commerce working to integrate career planning technology tools with the existing educational development planning process and career awareness and readiness strategies in the K-12 school system".
